**WHO:** Jack's Ride Against Cancer is a non-profit organization that was founded in March 2009, in memory of Jack Henry-Lee Gannigan. Jack was born on 12/21/05. He is the son of Melissa and Gottlieb and brother of Beth Gannigan. On September 24, 2007, a brain tumor, consisting of Medullablastoma was discovered via a MRI. On 9/27/07, Jack underwent a craniotomy, and resection of the tumor was successful. In October 2007, Jack began rigorous rounds of chemotherapy. In January 2008, Jack was in remission and what they thought would be his last chemo treatment was in February 2008. By April 20, 2008, he was out of remission, and earned his Angel Wings on May 24, 2008. This organization was established in his memory and combined with his favorite past time (riding on an ATV), to raise awareness to childhood cancer(s) while assisting cancer-fighting organizations. Children's Hospital of Wisconsin – Milwaukee and one of Marinette County's therapy programs will be benefiting from the proceeds of Jack's Ride 2009, while they lead the crusade to fighting childhood cancer(s).
